We were honored to be joined by Judge Wood and Sarah Murphy from the District Attorney's Office, who shared their support and encouragement for youth stepping into these roles. Families also saw firsthand how Peer Court helps students build leadership, accountability, and teamwork skills in a real courtroom setting.

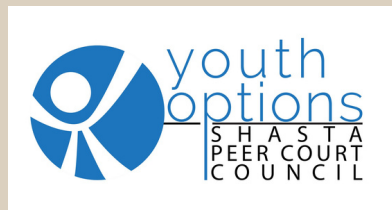
This event marked the relaunch of Peer Court for the 2025–26 school year, and we're excited to see the impact our new volunteers will make!

EXPANDING ACCESS:

Peer Court in Redding, Anderson & Shasta Lake

In years past, Peer Court was held exclusively in Redding at the Superior Courthouse. Beginning this year, sessions will be hosted in the City Council Chambers of Redding, Anderson, and Shasta Lake.

This expansion opens new doors for students and families across Shasta County to participate, bringing Peer Court closer to home and strengthening community connection.



YOUTH ACTION COUNCIL: New Members Leading the Way

In August, we launched a new Youth Action Council (YAC).

These student leaders will support Peer Court conferences, mentor peers, and share input on how YOS can best serve youth.

YAC members who have been accepted into the Peer Advocate Leaders Internship also receive a stipend in recognition of their leadership commitment and the valuable time they give to our mission.

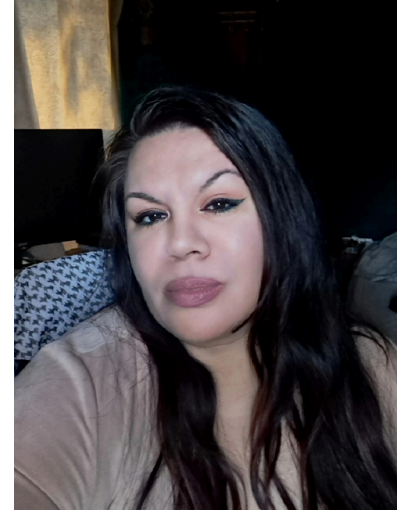


Welcome Our New Case Managers:
